Dear Friends.

Since the National Capital Mikvah opened in Georgetown in July 2005 it has been an amazing success — today, approximately 50 women per month immerse in our *mikvah* to observe the *mitzvah* of *taharat hamishpacha* (family purity). Ours is the only *mikvah* in downtown Washington, D.C. We operate seven days a week to help local families and visitors conveniently fulfill this important *mitzvah*. Our *mikvah* also plays a critical role in welcoming new converts to Judaism.

The National Capital Mikvah is proud of its beautiful facility. These facilities, however, incur numerous expenses including utilities, maintenance and supplies. We, therefore, depend on your generous contributions to ensure that people always have access to a pleasant, functional *mikvah*.

We have recently changed our membership structure to reflect non-profit best practices. Members will continue to enjoy use of the *mikvah* without paying an additional fee each time they use the *mikvah*. Please review the attached membership form for more details.

We hope you will continue to voice your opinions, volunteer your time and otherwise contribute to the success of the *mikvah*.

To coincide with these changes, we are also moving our annual membership drive from August to November to better align with end-of-year giving.
